


Making a Difference Through Pro Bono



Securing Justice for a Tenant Denied Due Process

Through the Cleveland Metropolitan Bar Association's pro bono appeals program, **Danielle Easton** and **Spencer Krebs** uncovered a critical error in a landlord-tenant dispute, where our client faced a \$15,000 judgment without having been provided notice of the motion for summary judgment in the first place. After successfully obtaining relief, the team is now defending our client's rights in municipal court.

Fighting for Asylum and a New Beginning
